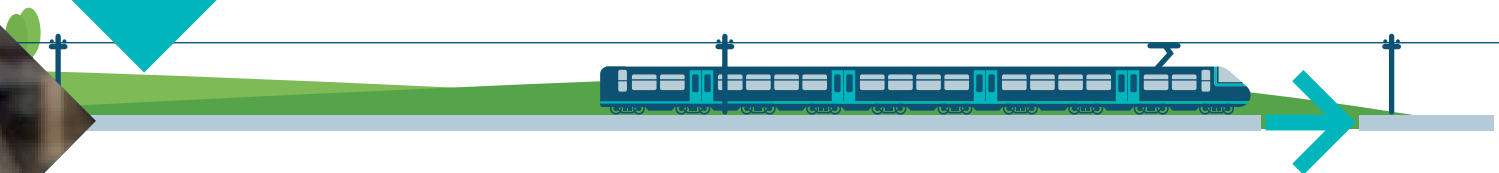

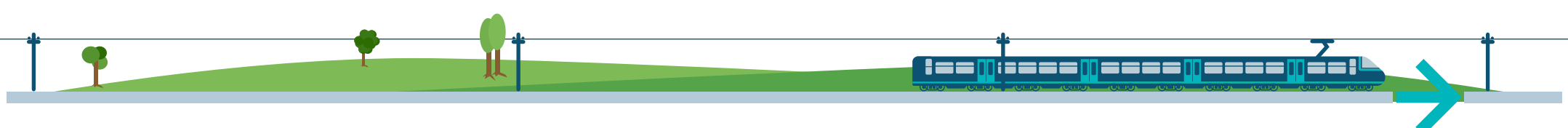

- This competence is an authority to work therefore any persons without the ERAs competence cannot complete an electrical risk assessment under NR/L3/ELP/SAI25
- Post course action learning will be required in order to pass the mentorship period (up to 6 months).

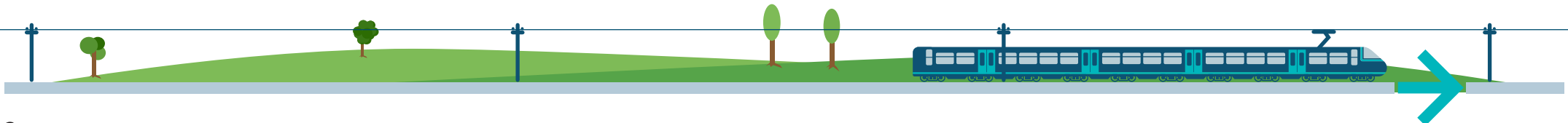

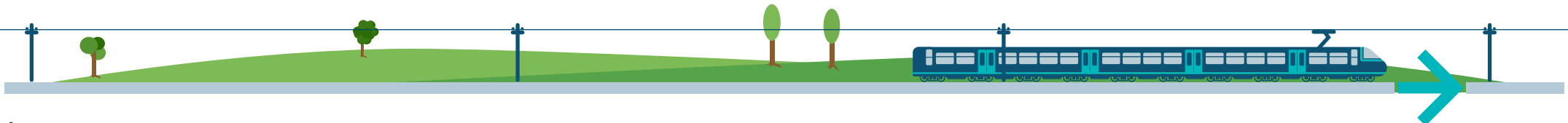

Those who are required to receive a detailed briefing will be advised by the implementation lead within their respective Company, Region, Route or Area.

The delivery methods may be different and will have been selected to best suit your area, but the content will be the same. Therefore, links to access the material and complete the briefs (inc. completion dates) will be provided by your leads.

E.g.: - Network Rail employees may be expected to view and record their briefs on the Business Briefing System, external Supply Chain may have a similar internal system. You may also receive these via a group brief and details recorded on a briefing form.

Detailed Briefings

Actions Required:

Once briefs have been completed, you will be required to inform the Sentinel Co-ordinator in your organisation / company to record completion and upload it on your Sentinel profile under 'Track Worker Safety'.

Therefore, it is advised that **all persons** involved in the deployment of NR/L3/ELP/SAI25 have a My Sentinel account to show proof of completion and understanding if and when requested.

Network Rail employees will find their Sentinel No. by accessing Oracle eBusiness → Competence Employee NR → Competence Profile

You will need to enter the following information:

Sentinel No. → First Name → Surname → D.O.B → National Insurance No. → Email Address → Set a security question and answer → Password.

Showing Proof of Completion:

Completion of the learning event will be visible on the Sentinel app as a 'Learning Event' under 'Track Worker Safety'.

Learning Event (app access)

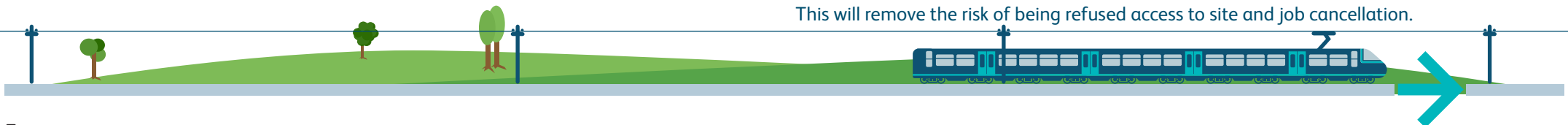
Scan your Sentinel Card via the app.

Learning Event (without app access)

Log into your My Sentinel account using your Sentinel No. and password.
My Profile → Learning Events → Track Worker Safety

It is recommended that you take a screenshot of your briefing completion prior to attending shift in case there is a delay in the upload to your 'My Sentinel' profile or the signal in the working location is too weak for app access.

This will remove the risk of being refused access to site and job cancellation.

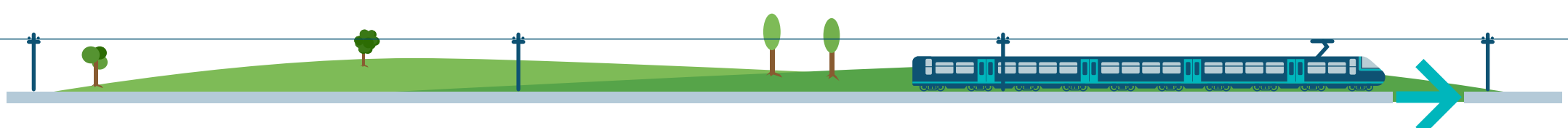

Pre-requisites:

- Must be an Electrical Control Operator. (ECO)

Key Information:

- Every ECO to be briefed in the area deploying NR/L3/ELP/SAI25.
- Relevant ECROM / Deployment Leads should ensure all ECOs have been upskilled prior to the 'Go-Live' of NR/L3/ELP/SAI25

● **Pre-requisites:**

- Must hold Controller of Site Safety (Overhead Line Permit) - COSS (OLP) competence.

● **Key Information:**

- COSS (OLP) competence holders should view the COSS (OLP) detailed brief before receiving an Overhead Line Permit under NR/L3/ELP/SAI25.

On Track Plant (OTP) Core – Machine Operators/Controllers & POSREP

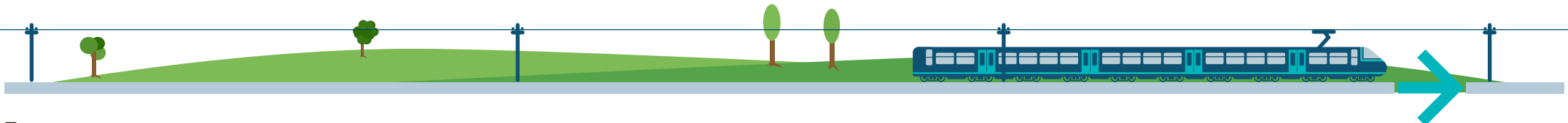
Sentinel Course Name: Machine Operator/Controller & POSREP: Briefing – Requirements of SAI25 2024

● **Pre-requisites:**

- Must hold the OTP Core competence (Machine Operator (MO) and/or Machine Controller (MC) and/or POSREP)

● **Key Information:**

- MOs/MCs are required to have the briefing before on/off/cross track or travel under live OLE for specified OTP under NR/L3/ELP/SAI25.
- MOs/MCs that have not attended a briefing cannot work with OTP where there is a need to on/off/cross track or travel under live OLE for specified OTP in areas deploying NR/L3/ELP/SAI25.



Work requestors

Local Record and/or Sentinel Event - Detailed Brief with commentary.
Work requestor definition: Person(s) with the requirement to undertake work on or about Overhead Line Equipment.

Sentinel Course Name: Work requestor: Briefing – Requirements of SAI25 2024

Key Information:

- Work requestors should make every effort to record the event through Sentinel. Local records should be utilised as a last resort and when a Sentinel I.D cannot be obtained.
- Work requestors should receive the detailed brief before they plan work around OLE, with or without an earthed isolation.
- The Electrical Risk Assessor (ERAs) may ask for a work requestor to have viewed the brief before requesting work through their earthed isolation provider.

Key Information:

- Level A (Distribution) staff should view the Level A (Distribution) detailed brief before working in an area deploying NR/L3/ELP/SAI25.
- Level A (Distribution) staff working in areas where NR/L3/ELP/SAI25 is not applicable, are not required to complete this briefing.
