




Forms

All NR/L3/ELP/SAI25 forms have now been relocated from the Standards and Controls website and onto the Safety Central website. Version control is now via a numeric/alpha format (Issue 1A/1B etc.)

- This action has been taken to ensure a more flexible route to form updates whilst we are in early deployment stages.
- Once early deployment has been concluded and DRACAS items addressed, all forms will be made available on the Standards and Controls website again.

All forms required for the implementation of SAI25 have had their references modified such that they are now prefixed with "ELP/SAI25"

E.g. The Electrical Risk Assessment Form reference was NR/L3/ELP/SAI25/ERAF, it is now <u>ELP/SAI25/ERAF</u>

This approach is in place while the SAI25 forms are outside of the Standards and Controls governance framework

Form updates will continue to be controlled and published via Safety Central

Forms shall not be modified locally and only those published via Safety Central are to be used when working to the requirements of NR/L3/ELP/SAI25
